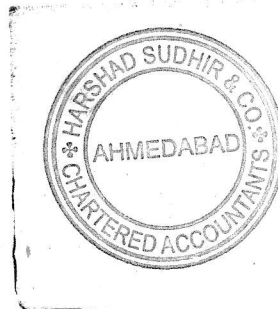
LIMITED REVIEW REPORT


